Hospitals now discharge patients "sicker and quicker". This means that you must recuperate some place other than a hospital.

Medicare and Medicare Supplements pay for only "Medically Necessary", skilled home health care on an intermittent basis, and NOT for services that primarily meet your personal care needs.

## **INDEPENDENCE & PRIVACY**

Remaining at home allows you to preserve your independence and privacy. Home recuperation is generally more effective because of the familiar and comfortable setting. No matter how nice nursing homes can appear they are still institutions, and have the sights, sounds and odors of an institution. You may have to share a room with one or more patients, which will result in the loss of privacy. Being in a nursing home too often secludes and isolates. Family, friends and neighbors will visit you at home, but often less frequently or not at all at a nursing home.

## INDIVIDUAL CARE-ONE-TO-ONE

One-to-one care at home can create a positive outlook, and may improve mental as well as physical function thereby enhancing the quality of life.

Most nursing homes have ONE nurse for every 25 patients, which is within legal guidelines.



## COST

Confinement in a nursing home may mean depleting your assets each month. Nursing homes cost approximately \$3,000 to \$5,000 per month and Medicare pays less then 2% of the cost.

Health conditions prior to the effective date of the Assisted Living Service Agreement are subject to a 6 or 12 month waiting period.

Those individuals with an immediate need for home care services are encouraged to seek other options or to engage Homeward Bound Services on a private pay basis.

**WAITING PERIOD:** A cost containment measure of 6 or 12 months in duration, that applies to all customers who have current needs or who may need services for a current condition.

# THE ANSWER YOU HAVE BEEN LOOKING FOR!

Case brought by two Georgia Woman several years ago asserted that their continued institutionalization was a violation of their rights under the Americans with Disabilities Act of 1990 (ADA) to live in the most integrated setting appropriate.

Both plaintiffs lived in state-run institutions, despite the fact that their treatment professionals had determined they could be appropriately served in a community setting. In its decision, the court observed that:

- Institutionalized placement of a person who can handle and benefit from community settings makes that person feel incapable or unworthy of participating in community life.
- 2. Confinement in an institution severely diminishes the everyday life activities of individuals, including family relations, social contacts, work options, economic independence, educational advancement, and cultural enrichment.



#### REQUIREMENTS FOR SERVICES:

- I) A phone call to Homeward Bound Services, Inc.
- 2) A "Plan of Service" agreed upon by the customer and Homeward Bound Services, Inc.
- 3) No claim forms to fill out
- 4) Immediate services are available anytime on a **Private Pay Basis**

#### REQUIREMENTS FOR BENEFITS:

- 1) Submission of "Claim Form" and bills to insurance company for payment
- 2) A statement by your doctor that care was Medically Necessary
- 3) Continual qualification of a cognitive impairment
- 4) Inability to perform one or more activities of daily living
- 5) You must find your own caregivers

#### WHAT IS PROVIDED:

#### ASSISTED LIVING SERVICES INCLUDE:

Bathing, Grooming, Toileting, Cooking, Meal Preparation, Laundry, Accompaniment to & from Doctors, Homemaking, Dressing, Shopping, Reminding to take medications, Assistance with household chores, and much more


#### WHAT IS PROVIDED:

- 1) Money; usually a stated dollar amount such as \$50, \$80 or \$100 per day. Most policies provide limited or no benefit for assisted non-medical ser-
- 2) You must find your own caregivers

#### TO QUALIFY FOR THE ASSISTED LIVING SERVICE AGREEMENT:

- I) Everyone accepted. We exclude only those presently hospitalized, terminally ill, or nursing home residents
- 3) Field issue. Service Agreement effective at time of application

4) NO AGE LIMIT!



#### TO QUALIFY FOR A POLICY:

- 1) You must meet strict underwriting requirements and many medical conditions are not acceptable for policy issue. In some instances, policy issue is limited or subject to a counter offer at a greater expense or a reduced policy benefit
- 3) Detailed application process for underwriting. Policy issue takes one to three months
- 4) AGE LIMITATIONS
- 5) You must find your own caregivers
